The evening leagues have been a struggle for Graham and we need members to give these games more support for next season.

Also under Graham's guidance and the coaching teams support, the club has regained a presence in the County League winning one of their games and finishing sixth in a league of seven.

The Tuesday evening combo. of coaching and playing built on the success of last year with a good attendance every week and our thanks go to JohnT and his coaches for the energy, freshness and fun they manage to bring to these evenings.

We have also seen an increase in the number of younger bowlers joining us in the evenings which is very encouraging and this has lead to *The Big Bash* event becoming a feature of Friday evenings. This has brought a short competitive game to these evenings with food being provided and a lot of fun being had by all. We must thank Chris and Janet for their efforts in getting this programme off the ground and growing our evening activities.

I hope that with the right support this will start a move back to the time when we had a much higher population of working members and the evenings were fully booked with two sessions most evenings.

Those of you who have been members for a few years will remember the agreement for the club to become a Limited Company which was agreed in principle two years ago. The reason for this was to reduce the individual members personal liability to £1 and give its officers more protection in carrying out their duties.

The need for this is brought into sharp relief by the need to sign the lease which is in the final stages of preparation To this end, work is ongoing to prepare all the documentation necessary for the transition of the club to "*A Company limited by Guarantee*' which is fully compliant with UK Gov and CASC requirements.

The ratification of this decision will be brought to the AGM together with the plan for its implementation at the earliest possible time during next year

Over recent years we have enjoyed a high level of stability in our Management team but the time has come when some members wish to step down and enjoy the benefits of the club for which they have worked so hard without their current responsibilities. This includes Peter and Elizabeth who have worked tirelessly over many difficult years to get the club to where it is now. We owe them an enormous debt of gratitude for their services and steering us through difficult times.

Mike Arnold is also stepping down as Membership Secretary having served for several years in this role and kept us in line at council meetings and kept you supplied with working key fobs!!
