GENERAL RULES FOR **ALL INTERNAL CLUB** COMPETITIONS

I] IF YOU KNOW YOU ARE NOT AVAILABLE ON FINALS DAYS (April 6th & 7th 2019) DO NOT ENTER.

II) THE LADIES AND MENS CHAMPIONSHIP, ALONG WITH ALL THE FINALS ARE TO BE PLAYED UNDER THE EIBA RULES FOR THE CURRENT SEASON. ALL OTHER MATCHES TO BE PLAYED WITH THE NUMBER OF ENDS AS SPECIFIED FOR THAT COMPETITION. DEAD ENDS TO BE RE-SPOTTED.

II] THE FIRST NAMED PLAYER, OR TEAM LEADER, IN THE DRAW IS THE CHALLENGER.

III] **THE CHALLENGER** IS RESPONSIBLE FOR ARRANGING THEIR MATCH ON OR BEFORE THE CLOSING DATE. BY MUTUAL AGREEMENT OR OFFERING THREE DATES ONE OF WHICH MUST BE AT A WEEKEND. FAILURE TO DO SO WILL RESULT IN THE CHALLENGER BEING DISQUALIFIED. UNLESS YOUR OPPOSITION REFUSES TO ACCEPT YOUR OFFERS THEN GO TO RULE VI. CHALLENGER MUST ALSO ORGANISE A MARKER.

IIIa] THERE IS NO REASON TO STOP THE OPPOSITION FROM CONTACTING THE CHALLENGER TO ASK FOR SOME DATES.[IF YOU KNOW YOUR NOT AVAILABLE FOR SOME TIME]

IV] **NO EXTENSIONS** ARE ALLOWED .EXCPET IF THE CLUB IS CLOSED DUE TO ADVERSE WEATHER CONDITIONS.

V] **RINK BOOKING**. THE CHALLENGER WILL HAVE THE CHOICE OF ANY **AVAILABLE** RINK ON THE AGREED DATE OF THE COMPETITION, PROVISIONAL BOOKING IS NOT ALLOWED AND ENTERED IN THE DIARY INDICATING WHAT COMP IT IS.

VI] A SCORE CARD **MUST** BE PUT IN THE APPROPRIATE BOX CLEARLY INDICATING THE RESULT, OR THE REASON A GAME HAS NOT BEEN PLAYED. NO CARD AFTER THE CLOSING DATE CHALLENGER IS DISQUALIFIED

VII] **SUBSTITUTES** TRIPLES,PAIRS,MIXED PAIRS, AFTER THE FIRST ROUND A SUB IS ALLOWED WHO CAN PLAY IN ANY POSITION OTHER THAN SKIP. [PROVIDED HE/SHE HAS NOT PLAYED IN ANOTHER TEAM IN THE SAME COMP.] ,IF HE/SHE SUBS FOR A THIRD TIME THEN THEY BECOME A FULL MEMBER OF SAID TEAM AND NO MORE SUBS WILL BE ALLOWED.

IVIII] SEE INDIVIDUAL PLAY SHEETS FOR THIER FORMATS.

[IX] ANY PROBLEMS OR DISPUTES SEE COMP SEC, IF IT CAN'T BE RESOLVED THEN WRITE TO THE COMMITTEE THEIR DECISION WILL BE FINAL.
